Minutes for Kerry Blue Terrier Club of Central Florida via Zoom Meeting

October 6, 2020

President Ron Ronald called meeting to order at 7:05 pm

Roll Call in addition to the President were: Chris Cagle, Kathy O'Brien, Eva Hansen, Linda Pheasant, Claire Pheasant, Barbara Bueter, Bob Beuter, Jack O'Brien, Juliana Palmer, Draper Palmer, Mark Findlay, Marcia Findlay, George Hanna, Judy Agnew, Linda Hickey.

- Minutes from last meeting were mailed out 10/04/2020. Barbara Beuter motioned to accept the minutes as they were emailed. Linda Pheasant second the motion.
- Report of the President. 8/24/2020 Special Board Meeting via Zoom regarding forming a nominating committee. Barbara Beuter accepted being Chair. Judy Agnew accepted being Trophy Chair for both Specialties. Ron Ronald is now Show Chair for both specialties as BLake Hansen has conflict and prior commitments. Discussion on the status of upcoming shows in January.
- Report of Secretary. Approval for both Specialties has been given by the American Kennel Club (January 22 and 23 of 2021). USKBTC has granted Kerry Blue Terrier Club of Central Florida approval for Specialties for the next 5 years.
- Report of Treasurer. Statement Balance \$2588.78. Paid out \$600 for Insurance and Donation of \$225 was made. MBF was given the information on trophies for the Specialties. Donations for trophies are needed.
- By Laws Committee. Working on drafting the Club's proposed new constitution and by-laws continues. Based on the Conclusions and Recommendations contained in the Committee's report to the Board and the Board's direction to start work on developing a new draft Constitution and By-Laws for the Club, we reviewed the current situation of the Clubs C&BL and decided to start from scratch. This decision was based primarily on the fact that no approved C&BL for our Club could be found in the National Club's files or in our Club's files. The only thing that could nbe found in National's files were proposed new C&BL documents from our Club and some correspondence between National and our officers on these proposals. The only written material we could find in our files was that which was contained in various publications of KERRY ON NEWS. To us starting from scratch meant looking at content and format of material first. It was suggested that we look at the National Club's C&BL document as a model for our product. That suggestion was accepted. So work began. The first step was to review the National Club document for material which was not pertinent to a Local Club and remove it from our draft document. This has been accomplished. Then step two, material from our current unapproved C&BL which was pertinent had to be added to our new draft C&BL document. This has been accomplished. Then step three, format this material into something that is useable. This under way. Hopefully we will have a draft document containing all of this information in a useable format for review at the next Board meeting.
- Show Committee. Approval for both shows (January 22 and 23rd). Supported entry with Manatee in the 24rth. Judges are Beverly Anderson on the 22nd and Robert Hutton on the 23rd. Sunday the 24rth is Duff M Harris.
- Unfinished business. Nominating Committee recommended to stay with the same slate of officers and board members as in 2020. All members agreed to rerun. Dinner at Papa Joes will take place on Friday January 22, 2021
- New Business. January Show update. Opening date is November 11, 2020. Waiver to be signed and brought with you and hand in when you pay for parking. Face coverings will be required when not showing. There will be separate in and out in each ring. As of right now there will be no trophy table or hospitality unless things change by show time.
