## AKC DEBUTS ONLINE DOG REGISTRATIONS

-- New Service Offers Ease and Convenience to Breeders and Dog Owners --

New York, NY - The American Kennel Club is pleased to announce that as of February 23, 2004 individual Dog Registration Applications will be accepted online at [www.akc.org](http://www.akc.org). This new service offers numerous benefits to both breeders and dog owners and follows the Online Litter Registration service launched by the AKC in October 2003.

"This initiative marks another milestone in AKC online services. The ability to register AKC dogs via a self-service web site is a tremendous convenience that we are pleased to offer our customers," said Dennis Sprung, AKC President and CEO.

Dogs may be registered online whether the litter registration was done online or in traditional hard copy form. The online process not only speeds and simplifies the new owners' registration experience, but also eliminates data entry by the AKC. At this time, the service is only offered for dogs with single breeders being sold to single owners.

Once online, he/she can complete all the required dog information (color, sex, etc.) and, if the dog has been sold, the breeder will also enter the new owner information. When this has been done the new owner can log on to complete the registration process. 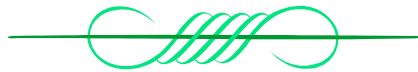

### Proposed change to the AKC Rules for awarding points at Dog Shows

The delegates to the AKC from dog clubs have proposed a change to the rules for awarding points at dog shows. More specifically this change applies to National Breed Specialties. The change would allow breed clubs to award points to the reserve winners dog and reserve winner bitch at a national specialty if the number of dogs or bitches shown in the winners classes at the specialty are twice the number required for a 5 point major. This proposed change is supported mainly by the delegates for the breed clubs about 80% for the change. The AKC has expressed concern about this proposed change in that it is possible for a dog to earn its championship without ever being the winners dog or bitch. It also opens the door for other questions according to the AKC, therefore they are asking the delegates to oppose this change. This proposed change will be voted on by the delegates at their next meeting the weekend of June 5<sup>th</sup>. Carl Ashby, Delegate from the US Kerry Blue Club has polled the Board of Governors and at last count it was 6 for and 4 against.

## Report from the USKBTC Board

The US Board of Governor's is currently involved with several projects that have been on going for some time. Among them are the changes to the Constitution and By-Laws and the revision to the Kerry Blue Standard. Both of these projects are moving forward, sometime at a snails pace. The USKBTC board was brought up to date on the status of both of these projects at the last board meeting in Texas. Bill Lynch, committee chair for the Constitution & By-Laws revision submitted proposed changes to the board for review. They are under review by the board at this time. As for the changes to the Kerry standard, Committee chair Anthony Lopez, presented change's proposed by the committee. The board approved the changes and they will now be sent to the AKC's Club Relations department for their review. If they are in agreement the board will then present these proposed changes to the USKBTC membership for vote. The procedure for revising the standard has been posted on the USKBTC website and are also printed in the current issue of Kerry Blueprints.

The handbook is still in-process with the hopes of having the handbook ready by Montgomery.

Gene Possidento has resigned as the Health & Genetics Chairman. Scott Kellogg has agreed to fill the position until the end of the year.

Kerry Blueprints is in need of an Editor again. Edie Brown is acting as publisher for the current issue.

The USKBTC has just been approved by the AKC to hold obedience trials.

The Board of Governors would like some feedback from the membership on how they feel about using e-mail to delivery the Kerry Blueprints in the future. Please express you opinions to the board.
