Raisins and Grapes are Toxic to dogs

This week I had the first case in history of raisin toxicity ever seen at our local emergency clinic. My patient was a 56 pound, 5-year-old neutered male Labrador mix who ate half a box of raisins sometime between 7:30 AM and 4:30 PM on Tuesday. He started with vomiting, diarrhea and shaking about 1 AM on Wednesday, but the owner didn't call my emergency service until 7 AM .

I had heard somewhere about raisins and grapes causing acute renal failure but hadn't seen any formal paper on the subject. We had her bring the dog in immediately.

In the meantime, I called the ER service at the emergency clinic, and the doctor there was like me—had heard something about it, but....

Anyway, we contacted the ASPCA National Animal Poison Control Center , and they said to give IV fluids at 1 1/2 times maintenance and to watch the kidney values for the next 48-72 hours. The dog's BUN (blood urea nitrogen level) was already at 32 (normal is less than 27) and creatinine was over 5 (1.9 is the high end of normal). Both are monitors of kidney function in the bloodstream.

We placed an IV catheter and started the fluids. We rechecked the renal values at 5 PM and the BUN was over 40 and creatinine over 7. The dog had no urine production after a liter of fluids.

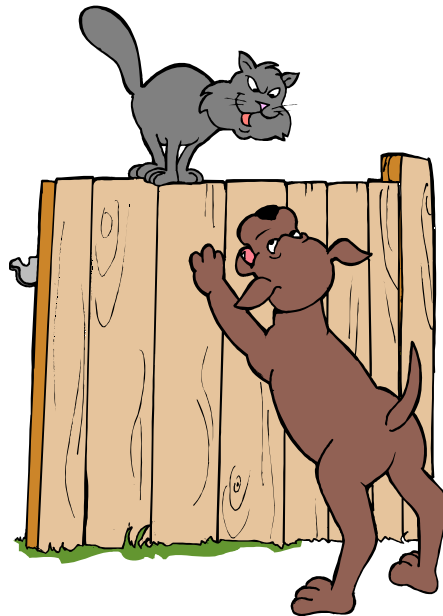
At this point I felt the dog was in acute renal failure and sent him to the emergency clinic for a urinary catheter. There they could monitor urine output overnight as well as provide overnight care.

He started vomiting again overnight at the emergency clinic, and his renal values continued to increase daily. He produced urine when given lasix as a diuretic. He was on three different anti-vomiting medications and they still couldn't control his vomiting.

Today his urine output decreased again, his BUN was over 120, his creatinine was at 10, his phosphorus was very elevated and his blood pressure, which had been staying around 150, skyrocketed to 220. He continued to vomit, and the owners elected to euthanize.

This is a very sad case. This Labrador was a great dog with great owners who had no idea raisins could be a toxin. Please alert everyone you know who has a dog of this very serious risk. Poison Control said as few as 7 raisins could be toxic. Many people I know give their dogs grapes or raisins as treats. Any exposure should give rise to immediate concern.

USKBTC Handbook

Hello everyone -

The Handbook will be at the printer very soon now. It is about 310 pages long.

The USKBTC Board of Governors voted at our Philadelphia meeting to offer the Chapter Clubs a chance to purchase the Handbook at a deep discount so that you may make some money on the sales.

The Handbook will regularly sell for \$15 plus shipping. "Puppy Packs" of six Handbooks will eventually be offered at a small discount, too, but that will not be for a while, maybe not before the Montgomery weekend in October. Sales to individuals are not being made at this time.

Chapter Clubs may now purchase the new Handbook in quantities of 40 at \$10 each, plus shipping. The books will be shipped directly from the publisher as soon as they are available. You may order as many as you wish, in units of 40, then re-sell them to your local folks. This offer will be available until the end of July, only. All Chapter Club orders at this discount must be made by the end of July.

When will they actually be available? Probably not until the first part of July. We do not have a definite date on that just yet.

Tom Rogers will be contacting the Chapter Clubs to determine where you will want the Handbooks shipped.

New Versatility Awards offered by the USKBTC

To honor those kerries that have demonstrated a level of versatility, the United State Kerry Blue Terrier Club has announced a new program of awards. The awards offer titles in those skills that an all-around farm dog might be required to do, along with some new events. The awards also honors those USKBTC members that worked hard training and competing in those various events. There are seven disciplines eligible for award tiers:

AKC Agility Title

AKC Conformation Title

AKC Obedience (with a CD or higher, or RA (Rally Advanced) or higher)

AKC Tracking Title

Earthdog Hunting Title (Hunting Certificate (HC) offered by the Am. Working Terrier Assoc.)

Flyball Title (Flyball Dog Champion (FDCH) offered by the North American Flyball Assoc.)

Herding Trial Dog Title (Herding Capability Title (HCT) offered by the Am. Herding Breeds Assoc.)

Titles offered in Earthdog, Herding and Flyball by the AKC will be included as they become available.

There are six tiers of awards:

Bronze Award - 2 titles required

Silver Award - 3 titles

Gold Award - 4 titles

Platinum Award - 5 titles

Emerald Award - 6 titles

Diamond Award - 7 titles
