**Minutes of the General Meeting

Saturday, June 18, 2005

Vice President Chris Cagle called the meeting to order at 2:00 pm. Nine club members were present, as well as two guests, Jack and Claire Kitson. After greeting the Kitsons, Chris explained that President Walter Bates has been hospitalized in Indiana and won't be back for a while.

**Secretary** Conni Adams read the minutes of the April meeting. A correction was made to read that Joan Lambert and Walter Bates would co-chair the January 2006 show. A motion was made by Anthony Lopez and seconded by Steve Adams to accept the minutes with the correction. Motion carried.

**Treasurer** John Waterman has resigned due to health problems. Joan Lambert will be appointed to continue as Treasurer at the next board meeting. Joan read and submitted a report to be added to the minutes.

**Committee Reports –**

**Ways and Means** - Anthony brought four sample candy bars to the meeting. Cost on the bars will be \$2.00 each. After discussion, it was decided to solicit donations from club members to cover the cost of purchasing the first 200 candy bars and to sell them for \$5.00 each. We will take 200 candy bars to Montgomery County in October.

**Show Report** – Joan cannot handle all the details of the show chair position. It was decided that she would handle the paperwork and the actual job would be done by committee. Kiki Kahn will judge the specialty and Lisa Favre will judge sweepstakes. The application to hold the show must be sent to AKC as soon as possible. The

judges should be contacted and the USKBTC needs to be contacted. Linda Lopez will contact Dan at the Clearwater Kennel Club and reserve the tent from the Tampa Bay Kennel Club.

**USKBTC** – Anthony reported that the revised breed standard had been approved by the membership and was being forwarded to AKC for consideration. The next issue of BluePrints will be out shortly. The new handbooks will be produced soon and USKBTC would like each chapter club to purchase 40 handbooks at a lowered price. The Club applied to be recognized in both earthdog and herding, but AKC rejected that application and requested the Club only apply for one activity at a time. The Board will poll members to see which they would prefer. Our members were in favor of herding.

**New Business –**

Linda researched purchasing medallions to use as trophies and other awards. The cost of the initial setup is \$85.00 and they are \$3.55 each for any quantity up to 100.

The Club may hold a B-Match with the Tampa Bay Terrier Club on October 29<sup>th</sup>. Conni is checking on also holding an AKC Rally Seminar with the match.

The next meeting will be held at the Manatee Civic Center on July 9th.

The meeting was adjourned at 3:00 pm.

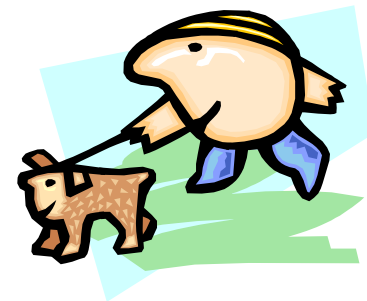
