

## Dog Show Barbie

This is a column that will appear for a short time. I thought you would get a kick out of this.

#### TRACKING JUDGE BARBIE

Barbie comes with a Polartec snowsuit, Gore-Tex rain gear and boots, wool socks, leather tracking gloves, silk long underwear, sunscreen, bug spray, a baseball cap, a waterproof clipboard, mylar paper and space pens in three colors.
