Minutes for Regularly Scheduled General Membership Meeting of the Kerry Blue Terrier Club of Central Florida

At the Central Florida Kennel Club Dog Show Saturday June 25, 2011 at Central Florida Fairgrounds, Orlando, FL

President Linda Lopez called the meeting to order at 11:25 am. There were fourteen club members present. The Minutes of the April meeting were approved as published in the May newsletter.

Treasurer Conni Adams read and submitted a financial report to be filed with the Minutes. It was approved.

Committee Reports - Membership - No new applications have been received.

Newsletter - Anthony Lopez would like any articles that might be of interest to the Club.

Historian - Eva Hansen provided a CD of photos from the January specialty for the website. Conni will get it to Bill MacLeod.

2012 Specialty Show - Chris Cagle had the application ready to be submitted to AKC. Discussion of Club policy resulted in the following resolution: Any person chosen to judge Sweepstakes shall not judge Kerry Blues at any other event for six months prior to our assignment. Neither the judge or the judge's immediate family will show during the day of the Specialty. A vote of the previously nominated people resulted in Lisa Favre being chosen to judge the 2012 Sweepstakes. Peter Machen is the Specialty judge. Trophy contributions will be recognized with a donation page listing all donors in the catalog. The dinner and annual meeting will be held Friday evening at Papa Joe's. A deposit has been paid to hold the meeting space. Saturday following the judging, the boutique, raffle and silent auction will be held along with a chili contest.

Unfinished (Old) Business –

Items for the Florida-themed Montgomery Basket were given to Tuesday and George Hanna to be arranged and taken to the shows. Members were urged to get their donations to Tuesday as soon as possible. A gift certificate redeemable for one night's stay (motel or RV parking) in Brooksville during the January specialty week will be printed and added.

The Club will offer a supported entry again this year in November with the Tampa Bay Terrier Club.

RDO Day is Saturday September 17th at the Florida State Fairgrounds. The Club will have a booth at the event and any who can attend with a dog are encouraged to contact Linda. Conni will send the contract to the Tampa Bay Kennel Club.

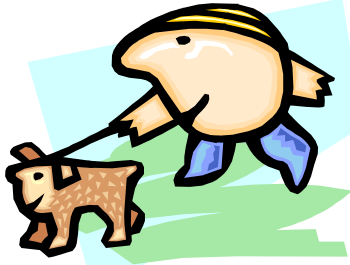
