1.0 Purpose

These rules are established as a guideline for the day to day operation of the Kerry Blue Terrier Club of Central Florida.

2.0 Scope

These rules are intended to supplement the Constitution and By-Laws of the Kerry Blue Terrier Club of Central Florida.

3.0 Definitions

4.0 Rules

4.1 Sunshine Committee (2)

In the event of the death of a member or family member of the Kerry Blue Terrier Club of Central Florida, the chair of the Sunshine committee shall have the authority to spend up to \$35.00 to be donated to a charity of the families choice. In the case of illness of a member, the chair of the sunshine committee shall send a card to the member.

4.2 Presidential Expenditures

The President of the Kerry Blue Terrier Club of Central Florida shall have the authority to spend up to \$100.00 without obtaining the permission of the Board of Directors. The Treasurer of the Club shall be consulted and if both agree on the expenditure, it shall be made.

4.3 Membership

4.3A First Reading

If a prospective member attends a meeting and submits an application at that meeting, this action along with a notice to be printed in the newsletter, shall constitute the first reading of that application.

4.3D New Member Dues

Any new member who joins the Kerry Blue Terrier Club of Central Florida From December 1st through April of the following year, shall be considered as paid for the following fiscal year.

4.3C

Applicant Without Sponsors

Any application received without sponsorship shall require that the applicant attend three functions prior to the application being presented for vote of the membership.

4.4 Judges Committee (2)

4.4A Judges Committee Chair

The chair of the sweepstakes or specialty shall also act as chair for the judges committee. The judge for either the sweepstakes or specialty shall be select by vote of the membership from a list of judges names submitted for consideration by the membership.

4.5 Club Historian (2)

- 4.5A The club historian shall be selected from the membership and is responsible for maintaining historical information for the club (ex: photo's of events, etc.)

4.6 Voting Count (2)

- 4.6A All votes taken by secret ballot shall be counted by three members in good standing as designated by the club president or presiding officer at the meeting at which the vote is taken.
